

- Sales in Denmark decreased slightly




Western Europé

- Several markets in the region performed well during the period, including Portugal, United Kingdom, Netherlands, Germany and Italy.
- The increase was attributable above all to the acquisition of Airwell, France, and Camair, Belgium.



Eastern Europé & CIS

- Sales increased notably in Poland, the Czech Republic and Slovakia.
- Sales in Russia decreased by 17 percent during the quarter.




North America

 The US market has increased during the period, while the Canadian retreated somewhat

- The markets in India and China showed good growth during the quarter.
- Development in the Middle East was good



Acquisitions during the period Menerga, Norway

- Menerga AS, market leader in swimming pool ventilation and distributor for Menerga products in Norway.
- The company is located in Hvalstad outside Oslo including a national service organization
- Achieved a turnover of SEK 55 million in 2014
- 17 employees



Acquisitions during the period Lautner Energiespartechnik GmbH

- Manufacturer of high efficiency rotary heat exchangers for air handling units and data center cooling
- Factory and headquarters in Helmstadt, Germany with 17 employees
- Expected turnover EUR 2 million
- Founded in 1991





Acquisitions during the year Airwell, France





- Manufacturer of air conditioning products for the commercial market
- The production facility in Tillières comprises 38,000 m²
- Estimated annual turnover of 30 million Euros
- 207 employees

Acquisitions during the year Camair, Belgium

- Supplying products for air conditioning and ventilation systems for the commercial market in Belgium
- Located in Seneffe 40 km south of Brussels
- The acquisition includes a modern property of 3,000 m² comprising offices, showroom and warehouse
- Estimated turnover of € 7 million for the calendar year 2014
- 22 employees



Acquisitions during the year Airwell, Germany

- Distributor of products for air conditioning and ventilation systems for the commercial market in Germany
- Located in Frankfurt with office and warehouse
- Estimated turnover of € 7 million for the coming year
- 15 employees


